Program of Study

Question A) : Your program of study (courses, assignments, course format). Add the exact number of class hours per course.

Bachelor of Science – Économie et Management, Free plan 3rd year bachelor

Courses:

Empirical Research in Management and Economics

6 ECTS, two 2-hour lectures per week, delivered in French

A1: Summary and presentation of a research paper of your choice (20% of grade) A2: Create and present a group research paper (80% of grade)

The course aims to allow students to develop the skills necessary to write an empirical research paper. It is taught in French, but all deliverables can be submitted in English.

Structure:

4 hours every Monday, divided into two two hour blocks. Each week has different types of sessions:

- "Plenary" sessions: they aim to present the organization of the course as well as the teaching staff. The choice of your research question is also discussed during these sessions. Note that there are only 2 "plenary" sessions, given during the first two weeks of classes.
- "Return" sessions: they allow each group to exchange one-on-one with teachers on their research project, throughout the semester. These sessions usually last 15 minutes per group, once every two weeks.
- 3. "Laboratory" sessions: they focus on the application of empirical methods in practice, through examples and exercises, and which can be used in the context of your respective projects. The sessions consist of a Q&A session related to the video of the day, or any other question related to the technical aspects of the labs/projects.
- 4. "Presentation" sessions: during these sessions, each group presents the article to be summarized and criticized (week 5), as well as its research paper (week 11-12).

Project Management

6 ECTS, one 4-hour lecture per week, delivered in French

A1: Simulation game (project charter is 25% of grade, final report is 25% of grade) Final Exam: 50% of final grade

Objective

This course underlines the reality of projects (ambiguous, fragmented, emerging and with a great political dimension) to help one manage them. This course is also a prerequisite for the Masters in Information Systems and it will addresse the 2 main approaches to project management: traditional approaches (waterfall) and agile approaches (Scrum).

Understand and master the different methods to manage projects (approaches and referentials)

Understand the technical aspects of project management (toolbox) as well as the related human and behavioral aspects Build, plan, manage, and close a project Learn how to ask oneself the right questions at the right time Know the essential elements to be implemented during each phase of a project

The course will include theoretical learning and practical learning through experiences related by professionals, a simulation game and workshop (Lego4Scrum et Lean management).

Market Design and the Economics of Asymmetric Information

6 ECTS, one 4-hour lecture per week, delivered in English

Final grade is based on two exams, both worth 50% of your course grade.

The first half of the course, all for exam one, aims to introduce students to one of the most applied areas of microeconomics - market design. This class is about how to design mechanisms to allocate scarce resources and how to create successful marketplaces and platforms. Different marketplaces have different tasks to accomplish. Practical market design that aims to design marketplaces that will be adopted, implemented, and maintained can be thought of as a kind of economic engineering.

The goal of part two, for the second exam, is to introduce students to the economics of asymmetric information. At the end of this part of the course students should know that informational asymmetries can lead to market failures and that there exist decentralized solutions (e.g., signaling and screening) and centralized solutions (e.g., mandatory insurance) that can reduce or prevent these market failures. Students should also know that informational asymmetries can cause welfare losses in contractual relationships not mediated by a market and that contract theory shows us how to reduce or prevent these welfare losses.

Principles of Finance

6 ECTS, one 3-hour lecture per week and one 1-hour DGD per week, delivered in French

Entire grade (100%) is based on the final written exam in June.

In this course you will learn to analyse investment project and understand how to manage a portfolio. We will discuss valuation of assets and determine how companies should pay dividends. We will also show how to use and price options. It's kind of a step up from ADM 2350.

Italian Language (B1)

3 ECTS, one 2-hour lecture per week and one 45-minute DGD per week, delivered in French



Course goals include participating in common conversations, understanding presentations on general topics, reading texts in a familiar field, writing structured texts to convey information or opinions, navigating basic intercultural differences, and using self-directed work techniques. A proficiency test was mandatory to be placed at the right level to enter the course.

Preparation and Arrival Timetable

Preparation Phase:

- Mid-July 2023: Created an account on fmel.ch for residence
- November 10th, 2023: VISA Application mailed to Swiss Consulate in MTL
- November 13th, 2023: UNIL contact you with all necessary information to register under FMEL (residence) and the Canton of Vaud (the region in Switzerland where Lausanne is)
- Beginning of December 2023: Registration opened, and residence secured on fmel.ch

Travel and Arrival:

- October 24th, 2023: Booked flight from YYZ⁰ FRA⁰ GVA one-way ticket, CAD 397.72 (booked through AMEX)
- January 25th, 2024: Arrived in Geneva via Toronto and Frankfurt, then trained in Milan to stay with family
- February 1st, 2024, 3 PM: I arrived in Lausanne, took the M1 from Lausanne Flon to EPFL station, and moved into the Atrium residence.

Settling In:

• February 12th, 2024: Welcome week started with weeklong friend-making and Swiss-touring activities

Academic Schedule:

Arrival Procedures

Question 3: Procedures to follow upon arrival. List and description of services offered by the International Exchange Office of the host institution. Registration and course selection. Social activities.

Upon arrival:

- 1. Present yourself to the township in which you are staying. For me it was Ecublens, VD. It depends on where your residence is, and you need to check their specific arrival requirements and costs to register with your township.
- 2. Then, you must mail either your exemption from Swiss health insurance with proof of your existing healthcare or your Swiss health insurance.
- 3. Head to the UCU equivalent at UNIL, the Unicentre, the week before school starts, and claim your student card and welcome package.
- 4. After a few weeks, you'll receive a letter to head to downtown Lausanne to perform biometrics. This costs 20 CHF. This will secure your arrival in Switzerland and trigger the canton to mail you your residence card! This officially certifies your legality to be in the country. I received mine on February 26th, and I started the process on February 2nd (going to the township of Ecublens to get registered)
- 5. Follow ESN UNIL/EPFL on Instagram to stay in the loop with exchange student activities.

I personally didn't use any of the exchange office services. Everything you need to know is on the Swiss consulate and UNIL websites.

- November 10th, 2023: VISA Application mailed to Swiss Consulate in MTL

- Beginning of December 2023: Registration opened, and residence secured on fmel.ch
- The housing deposit will depend on your residence. Mine was 1200 CHF, and I wired it mid-December after securing my residence.

I have three roommates, and we share a common area and kitchen. In the kitchen, you have your cupboard and share the fridge.

I have a desk, closet, shelves, single bed, nightstand, private bathroom, and a huge window in my private room.

It's a good location.

- 10-minute walk / 5-minute train / 5-minute bike to UNIL campus
- 20-minute walk / 10ish minute bike to UNIL sports centre and Lac Leman
- 15-minute train / 25 min bike to downtown Lausanne

I recommend getting a PubliBike account and biking everywhere instead of the TL Monthly pass for the metro. Rent: 740 CHF / month + 1200 CHF initial deposit

Summary

Extra stuff to keep in mind and Recommendations

- Take the first week of classes to visit as many courses as you can.
- Sign up for courses on Moodle, which is like Brightspace, and also register for exams on the UNIL platform (UNIL will email you about it)
- DO NOT TAKE PUBLIC TRANSIT WITHOUT A TICKET you will be charged 100 CHF if caught.
- A half-fare card from SBB will get you half off on all transportation within Switzerland.
- The dryers here suck you'll end up airdrying your clothes
- Download TheFork app to get 20%-50% discounts on restaurants in Lausanne
- Download LaCarteGreen to get student discounts
- Get involved in student societies to meet people! I recommend scoping them out before your exchange and reaching out because some clubs' onboarding process is somewhat lengthy.
- The economy shuts down on Sundays, so make sure you have groceries for Sundays. In other words, the majority of businesses close on Sundays

My Personal Summary

This is such a fantastic country. Aside from the expensive cost of living, UNIL and Europe are generally rich in culture everywhere you turn. The people here have open arms; surprisingly, many speak English. I've been able to play drop-in basketball, join the Investment Society, join the Entrepreneur Society, ski for the first time, make friends with locals and exchange students, and travel to 6 countries in my first two months. I'm thankful to be able to leverage my trilingual tongue since the non-Swiss UNIL students are either French, Italian, or English speakers from elsewhere. The food quality here is superior to Canada's; the transport systems are functioning and reliable, the weather is milder, and the school isn't too hard. I would say that this is a fantastic European experience so far with new core memories made, but be prepared to spend more money compared to the rest of Europe.
