**GUIDELINES FOR THE LIST OF EXAMINERS**

1. The list of examiners is proposed by the student in consultation with his or her supervisor. The student must ensure that this form has been completed and forwarded by making a service request in his or her Candidate Center (uoZone). The list must be submitted at least one month before the filing date. Any delay will delay the entire evaluation and defence process and may have financial consequences since the submission of the thesis cannot be accepted if the list of examiners has not been submitted.
2. A master's thesis jury must consist of two to four examiners.
3. A doctoral thesis jury must consist of four to seven examiners of which at least three must be internal and one external.
4. The list of examiners for a doctoral thesis must include the name of a potential external examiner from a different North American institution along with a brief CV and a complete list of publications. If necessary, the name (CV and list of publications) of a second potential external examiner might be requested by the Academic Unit.
5. The proposed external examiners should be free of any conflict of interest with regard to the PhD candidate, the candidate's supervisor and the candidate's co-supervisor.

**Examples of conflict of interest:**

- A proposed external examiner has worked for the same university, organization or department or has been part of the same research unit as the supervisor(s) or the candidate in the past six years.
- There is an administrative or family link between the proposed external examiner and the supervisor(s) or candidate.
- A proposed external examiner is an industrial or government representative who has been directly involved in collaborations with the supervisor(s) or candidate in the past six years.
- A proposed external examiner is a former research supervisor, graduate student, or postdoctoral trainee of the supervisor(s).
- A proposed external examiner has collaborated or published with the supervisor(s) or candidate within the past six years.

This list, while not exhaustive, illustrates the nature of potential conflicts to be avoided.
